

The UN Sustainable Development Goals 2030 Approaches for Volunteering Involving Organisations

The Centre for Volunteering recognises that its' work and advocacy encompasses international goals in relation to Social Responsibility including Corporate Social Responsibility (CSR) and its adjunct, the Sustainable Development Goals (SDGs).

“Poverty eradication is at the heart of the 2030 Agenda, as is the commitment to leave no-one behind.”¹ The SDGs came into effect in January 2016, and they will continue to guide United Nations Development Programme policy and funding until 2030. The United Nations states that the SDGs are “a universal call to action to end poverty, protect the planet and ensure that **all** people enjoy peace and prosperity.”² The SDGs acknowledge that in order for them to be properly utilised within a society, that society needs both peace and security to exist within it. Further, it is acknowledged the SDGs may be implemented in different ways and in different modes by different societies. Ultimately, there is NO one prescriptive method by which SDGs may be realised by organisations including Volunteer Involving Organisations.

The SDGs allow all organisations, whether small local enterprises, Volunteer Involving Organisations (VIOs), multinational corporations or states and nations, to make decisions in relation to how they conduct their operations to benefit not just themselves but to society as a whole. Investment in the SDGs adds to human capital and growth in all societies and is the ultimate goal of the UN SDGs. Primarily, the SDGs provide ideals and goals which then may be turned into actions and targets for organisations to implement, taking into account their own resources and challenges.



Goal 15

Protect, restore and promote sustainable use of terrestrial ecosystems, sustainably manage forests, combat desertification, and halt and reverse land degradation and halt biodiversity loss

15.1 By 2020, ensure the conservation, restoration and sustainable use of terrestrial and inland freshwater ecosystems and their services, in particular forests, wetlands, mountains and drylands, in line with obligations under international agreements

The UN Sustainable Development Goals are particularly beneficial in the context of the operation of VIOs as they allow individual VIOs to assess and examine their own processes in the context of the sustainable development goals. This means that operational procedures particular to a VIO can be isolated and analysed by the VIO in terms how they fit into the SDG target and goals.

It is to be noted that "Volunteerism is one of the most basic expressions of solidarity and societal cohesion, often arising out of long-established traditions of sharing and reciprocal exchanges."⁴
